To do this, non-standard applicants in this category will be interviewed, and may be asked to produce a piece of written work as a means of assessing their suitability.

## Distinctive Features of the Course:

---

- A unique characteristic of the course, setting it apart from other Design and Applied Arts Masters provision, is the broad range of opportunity that exists, including material options in Ceramics, Glass, Interior Design, Fashion or Textiles. The Wolverhampton School of Art provides an excellent resource to assist you in achieving your ambitions. This is further enhanced by our network of industry based contacts that can assist in supporting you with your manufacturing and production requirements should the facility not exist within our own provision.
- Your study route is defined by your chosen research project. The project becomes a vehicle for the development of your creative abilities, problem solving and analytical skills, and for locating your work within the business and professional world or academic research community.
- Collectively, the workshops are among the best educational provision in the U.K., and you will be taught by renowned, internationally recognised practicing designers, artists and researchers involved in a range of professional practices, exhibitions and publishing.
- Your Masters Project in DAA requires you to present your work to an external audience in an appropriate format. This is normally in the form of an exhibition, symposium or on-line presentation. This offers a further opportunity to present your work to industry professionals, fellow researchers and other interested companies and organisations.
- The Wolverhampton School of Art has been formally recognised for its research excellence. There is a vibrant and supportive research community within the Wolverhampton School of Art and CADRE (Centre for Art, Design, Research and Experimentation) provides excellent enhancement to your studies.
- A series of research methods workshops in the preparation of your Masters Project in DAA will facilitate your ambition to progress to further academic research (MPhil/PhD).

### Educational Aims of the Course:

The focus of post-graduate study in Design and Applied Arts is to question your current and past practice and recognise the opportunities that exist for research, design thinking, material investigation, professional development and career opportunity. The aim is to provide a framework that will guide your enquiry within the specialist investigation of Ceramics, Glass, Interior Design, Fashion or Textiles. Your specialist practice will be recognised in your final award title, for example, MA Design and Applied Arts (Glass).

We aim to introduce you to a range of approaches in the analysis and debate of material practice related to applied arts and design driven outcomes. Your practice will be supported by specialist academics and the physical resource required to become expert in your particular area of glass, ceramics, interior design, fashion or textiles.

You will develop the ability to locate your practice within critical, theoretical, professional and cultural contexts, enabling you to achieve a high level of subject specific knowledge and expertise, informed by creative thinking and theoretical enquiry. You will strengthen your ability to exercise initiative and take personal responsibility for your learning through independence.

We recognise that in the contemporary creative industries, collaborative and cross disciplinary activity is essential. The MA in Design and Applied Arts additionally promotes the opportunity to work across disciplines, for example, Textiles and Interior Design; Glass and Ceramics. Further cross disciplinary activity and team work can occur in modules that are shared between courses across the Wolverhampton School of Art, and in some instances, the University. If you choose to work across disciplines your final award title would be MA Design and Applied Arts.

The promotion of self-management, communication, and analytical skills prepare you for entry into a wide range of careers. The course is also designed as preparation for study at MPhil and PhD levels.

MA Design and Applied Arts will provide you with the opportunity to establish a career in design, practice and/or industry in the UK and internationally. Many graduates will be looking towards establishing themselves in their own business, or as a sole trader or freelance designer. The course is specifically designed to promote entrepreneurship through business start up schemes such as the SPEED project.

The MA Design and Applied Arts programme also supports students who wish to engage in further academic study and study research degrees. A number of students successfully undertake their PhD's (research projects) within the University of Wolverhampton and other institutions nationally. The MA in Design and Applied Arts supports this development through additional Research Methods training workshops, which will help to develop your understanding of research, and support you in your preparation of proposals for future research study.

Portfolio working is often a feature of graduates working in the design/maker/craft sector and for many designers and makers, professional practice comprises several activities. These often centre round the cultural and creative industries and many of our graduates are involved in community projects, curatorial practice and gallery work. To support this career trajectory MA Design and Applied Arts students are equipped with a range of transferable skills which include entrepreneurial, project management and marketing experience, the ability to initiate, reflect and problem solve in a range of situations and the presentation skills appropriate to working in a variety of professional and academic situations. The MA course operates within a strong network of outside agencies such as the Crafts Council, Arts Council England, Design Maker West Midlands and Business Link to help ensure we can assist you in the best way possible for employment.

The Workplace assists students in securing work placements, undertaking live briefs, engaging directly with employers and developing key employability skills. The Wolverhampton School of Art is committed to raising student awareness of the opportunities that exist post-graduation. An option module in Professional Practice and Enterprise is available to enhance preparation for career destination.
