The MA English offers the opportunity to learn from world-leading research and teaching staff in a friendly, supportive environment. The programme features:

## Educational Aims of the Course:

---

The MA English course aims to provide a stimulating intellectual environment that will enable graduate students to build upon their interests and skills at postgraduate level. It features core modules in both advanced critical theory and research methodologies that will deepen and develop graduate abilities in academic research, writing and presentation to meet professional standards. These standards will be evident in a final dissertation, based upon students' intellectual interests and supported by one-to-one tutorials with a supervising academic who has research expertise in the field. Students will also be guided through the transition from undergraduate to postgraduate study through six taught modules. These seminar-based modules will be taught weekly and will be drawn from

1. For the Literature strand, three distinctive themes relating to literary genres in history, major author study and literary adaptations. Featured authors and texts will range from Byron and Milton, through Virginia Woolf and the Neo-Victorians to 1930s working class writing and current adaptations of the work

of Sarah Waters.

2. For the Language and Linguistics strand, students are offered a range of modules covering key themes and concepts central to the study of English language and linguistics. Topics include discourse and text analysis, lexicology, pedagogic grammar, and theories of language learning and processing.

This MA can be studied in both full-time and part-time modes, and completed in either a year or just over two years.

## Teaching, Learning and Assessment:

---

Taught MA modules will be taught through weekly seminar groups, supported (where appropriate) by directed reading, on-line tasks and discussions, field trips and archive visits. The dissertation will be written under the guidance of a supervising tutor supported by a combination of one-to-one tutorials and online dialogue.

Specific activities will include: concept definition; online forums; bibliographic exercises; identification and evaluation of on-line and paper archival resources; scholarly editing and annotation. Each of these will inculcate intellectual creativity and a high-order ability to comprehend and synthesise complex ideas into a coherent train of thought. Students will apply independent judgement to a range of ideas from writers and thinkers drawing upon a range of global perspectives.

Each of these activities will be transferable to, and of value within, the workplace. They will produce students who are confident in the research and authorship of professional documents, exhibit advanced competences in digital literacy, and who will have encountered a range of global creative and intellectual sources of information.

### Assessment Methods:

---

At the University of Wolverhampton, a variety of modes of assessment will be used to support and test your learning and progress and to help you develop capabilities that are valued beyond your University studies and into your working life. Your course may include a variety of assessment activities:

Written examinations (including online examinations, open and closed book examinations and quizzes)  
Coursework (for example, essays, reports, portfolios, project proposals and briefs, CVs, poster presentation)  
Practical (for example, oral and video presentations, laboratory work, performances, practical skills assessment)

In the final year of your undergraduate degree, and at the end of your postgraduate degree, you are likely to be expected to write an extended piece of work or research, such as a dissertation or a practice-based piece of research.

### Student Support:

---

The taught programme is underpinned by two modules, *7EN001 Texts and the Critic 1: Advanced Critical Theory* and *7EN002 Texts and the Critic 2: Research Methodologies*. The former will provide an advanced introduction to the literary and cultural theories that continue to provide the basis for much scholarly research activity in academic research. The latter will train students in accessing, evaluating and applying a range of research resources including archives, databases, bibliographies, academic journals and other publications. It will ensure students adopt a systematic and detailed use of academic conventions in presenting their work to a standard appropriate for publication.

The remaining modules will be taught by lecturers whose research specialism will inform both the content of the modules and also their experience of professional publication and engagement with a wider academic environment.

### Employability in the Curriculum:

---

The MA English qualification is a source of continuing professional development for individuals already engaged in professions such as teaching, journalism and careers within local government and the public sector. On a much broader scale, the programme will also enhance the individual qualities needed for employment in circumstances requiring sound judgement, very good communication skills, personal responsibility and initiative in the professional environment.

The MA will also provide a sound intellectual and stylistic platform for students to progress on to doctorate level study and a career in higher education.
