Teaching, Learning and Assessment:

Teaching and learning

Teaching will be a combination of online lectures and self-directed study.

Theoretical assessment

This takes the form of a 20-minute viva voce conducted online. Students will be examined by two NIPE trained assessors. The subject is a case-based discussion of a baby requiring one of the NIPE areas that is examined in detail and an overview of the whole examination (LOs 1, 2 3 & 4).

Formative assessment

A ten-minute practice viva voce is available to the students three weeks prior to their summative assessment.

Assessment of competence in practice

Students must complete 40 full NIPEs in practice under the supervision of a current NIPE practitioner. The portfolio will be digital and used to demonstrate the student's competence (LOs 1, 2 3 & 4).

Assessment Methods:

At the University of Wolverhampton, a variety of modes of assessment will be used to support and test your learning and progress and to help you develop capabilities that are valued beyond your University studies and into your working life. Your course may include a variety of assessment activities:

Written examinations (including online examinations, open and closed book examinations and quizzes)
Coursework (for example, essays, reports, portfolios, project proposals and briefs, CVs, poster presentation)
Practical (for example, oral and video presentations, laboratory work, performances, practical skills assessment)

In the final year of your undergraduate degree, and at the end of your postgraduate degree, you are likely to be expected to write an extended piece of work or research, such as a dissertation or a practice-based piece of research.

This module is offered at Level 6 and Level 7 study.

Level 6 study assures employers of a registrant that is capable of undertaking the enhanced responsibility of

the assessment in clinical practice. Level 7 study will be considered towards scholarly progression to a master's qualification.

This is a practice-based course and is specifically designed to enhance practitioners' skills in their current role. The course is now integrated into a three year BMid midwifery degree, this course will enable practitioner who did not qualify with this course to upskill themselves and enhance their employability prospects within practice.
