Students who do not have a first degree, but have successfully completed Level 6 Continuing Professional Development (CPD) modules, or who can provide evidence of their ability to pursue successfully the PGCert or MSc may be considered eg completion of an approved preparation course for level 7 study. Such applicants will be invited to discuss individual needs with the programme leader to determine suitability for study at master's level.

Overseas Student:

If English is not the applicant's first language they will need to have a TOEFL score of 550 or above, or an IELTS score of 7.0 or above in each of the IELTS categories.

It is suitable for experienced nurses who wish to advance their professional career and contribute to the delivery and future development of specialist clinical nursing care in order to enhance the quality of the service users and carers experience. This is achieved by maintaining high standards of knowledge, skills and proven abilities through the education of specialist clinical nurses.

This course values strong clinical nursing leadership and encourages accountability for ensuring a high quality and patient-centred care experience for individuals and their families. Content is based on advancing theory, principles and role concepts of specialist clinical nursing and can facilitate your practice to an expert level as defined by Patricia Benner (1984) in *From Novice to Expert; excellence and power in nursing practice*. You will utilise a research and evidence based approach designed to inform your specialist nursing practice in the core central tenets that underpin specialist care.

You will develop valuable knowledge and skills in communication and clinical nursing leadership and the ability to articulate and advocate on behalf of the service user and carer which is central to the role of the

specialist nurse in practice.

Teaching, Learning and Assessment:

As part of your studies you will come into contact with a range of activities designed to promote and enhance your learning and apply new knowledge to the specialist clinical nursing field. Our use of interactive and blended learning activities encourages you to develop digital literacy and address particular learning needs related to your own development.

Lecture

Core content will be delivered in a variety of lecture formats; both teacher and student centred lectures are encouraged. Within the lecture, time will be provided where you are encouraged to be interactive with lecturers to aid clarification and extension of your knowledge and understanding.

All lectures will be supported by digital materials to enhance learning, and made available for you to access independently through CANVAS (Wolverhampton's own virtual learning environment).

Debate and dialogue

Participatory learning activities are integral to lectures and seminars and CANVAS provides a forum for you and your colleagues to engage in dialogue with each other as well as with academic staff.

Tutorials

Face to face meetings with the module team, your personal tutor and your Course Leader ensures that you receive academic advice and support to meet your individual learning needs.

Digital Literacy

The willingness and ability to use digital technology and electronic resources effectively is a key attribute of postgraduate work and will enhance the quality and efficiency of your learning as well as facilitating your specialist nursing practice. Use of ePortfolio for the specialist clinical nursing practice module will facilitate the development of a lifelong resource for CPD that will enhance your lifelong learning as a specialist clinical nurse and professional.

Learning in the workplace

The course is designed to ensure that theoretical learning helps you to acquire, hone and maintain practical specialist clinical nursing skills in the workplace. In particular, the specialist clinical nursing practice module outcomes are assessed within the workplace, via a tripartite arrangement between you, your mentor/employer and the University of Wolverhampton. Skills must be maintained and academic evidence provided in support of your specialist nursing skills; this will be documented within your own personal and professional ePortfolio.

Independent and self-directed learning

These are essential aspects of becoming a Master of your chosen field. Module Leaders will ensure essential reading materials (including web based resources) are made known to you. In each module there will be a degree of freedom for you to explore topics of your own choice in the context of specialist clinical nursing and the module specific learning outcomes.

To achieve this you will be encouraged to seek out and review material additional to that recommended by module leaders to support your academic and professional development and to dedicate sufficient hours of study to enable you to complete the module coursework within the timeframe set.

- Personal tutorial support both online and face to face
- Dedicated course and module team
- Assessment of academic ability and study skills will be an integral component of each summative assessment in each module

Our course teams have worked closely with employers and key stakeholders to develop a framework of core knowledge and skills and ensure a nationally consistent approach to specialist clinical nursing in the specified field. The need to put the patient at the forefront of all decision making is essential and the specialist nurse is in a uniquely privileged position to ensure that this is done.

This course, as well as preparing for and developing your specialist clinical nursing role and practice, can also be the first step to further academic qualifications. Further study is available to progress in your studies at level 7 and achieve a Postgraduate Diploma in Nursing and ultimately an MSc Nursing.

Participating in academic study at this level will encourage analysis and criticality; this will continue to improve the experience of the patient and may offer significant opportunities for promotion and career advancement.
