Overview of Assessment:

As part of the course approval process, the course learning outcomes were mapped to each of the modules forming the diet of the programme of study. Learning Outcomes

Modules

UGCRED01 Critically evaluate local and national influences impacting upon the delivery of palliative and end of life care.

UGCRED02 Critically analyse the evidence underpinning multi-professional practice relating to holistic care for individuals with a life limiting progress diagnosis.

UGCRED03 Demonstrate an understanding of the roles of the multi-professional and multi-agency teams and promote collaborative working and appropriate referral in palliative and end of life care.

UGCRED04 Critically reflect on the ways in which your personal coping style, attitude, experiences and understanding of loss, grief and change impact upon your practice.

Teaching, Learning and Assessment:

The module will be delivered through a combination of lectures and group discussions. Some material may be pre-recorded and made available through our virtual learning platform Canvas. This material will serve as a learning trigger which will stimulate discussion and activities during on-campus workshops. Workshop activities will provide a mechanism for providing you with feedback on your progress. These formative activities are designed to help you work towards completion of the module assessment. The module is assessed by completion of a 3,000-word written case study which is linked to your clinical support of patients on palliative and end of life care pathways. You will be asked to critically appraise local and national policies and provide an evidence-based discussion supporting the approaches taken to care for your patient; this will include the roles of multi-agency teams. Feedback on your final assessment will be provided through Canvas.

Assessment Methods:

At the University of Wolverhampton, a variety of modes of assessment will be used to support and test your learning and progress and to help you develop capabilities that are valued beyond your University studies and into your working life. Your course may include a variety of assessment activities:

Written examinations (including online examinations, open and closed book examinations and quizzes)
Coursework (for example, essays, reports, portfolios, project proposals and briefs, CVs, poster presentation)
Practical (for example, oral and video presentations, laboratory work, performances, practical skills assessment)

In the final year of your undergraduate degree, and at the end of your postgraduate degree, you are likely to be expected to write an extended piece of work or research, such as a dissertation or a practice-based piece of research.
