There must be funding arrangements in place before acceptance and that the Masters would normally be completed in five years from commencement of the Post Graduate Diploma/ NMC qualification..Applicants who may have completed a postgraduate professional award from another AEI will be asked to provide evidence of recent research study.

As a "Top Up" Masters, it is expected that the student will be able to undertake research in their area of specialist community nursing practice which lends itself to improved future primary health care practice and publication which will be attractive to health and social care organisations..

Teaching, Learning and Assessment:

Students will have a number of directed taught modular sessions, individual research supervision support and

self directed study to progress the "Ethical approval and Research" process in:

- Deciding on the topic / methodology and ensuring this is feasible to conduct in the timeframe,
- Preparing the research proposal,
- Ethical committee approval (all research is required to go to the School of Health & Wellbeing ethics subcommittee. Additional ethical approval processes may then be required following School ethics approval, this will depend on your unique study),
- Collecting the data,
- Managing the data;
- Writing the dissertation.

Assessment Methods:

At the University of Wolverhampton, a variety of modes of assessment will be used to support and test your learning and progress and to help you develop capabilities that are valued beyond your University studies and into your working life. Your course may include a variety of assessment activities:

Written examinations (including online examinations, open and closed book examinations and quizzes)
Coursework (for example, essays, reports, portfolios, project proposals and briefs, CVs, poster presentation)
Practical (for example, oral and video presentations, laboratory work, performances, practical skills assessment)

In the final year of your undergraduate degree, and at the end of your postgraduate degree, you are likely to be expected to write an extended piece of work or research, such as a dissertation or a practice-based piece of research.

The student will be given contact details including the name, telephone and email address of the above support services via the module guide and course handbooks.

Within the induction programme there are dedicated face to face sessions on study skills, referencing and details on how to contact and access the above support services. Students will also be informed about the range of electronic study skills support available to them on a regular basis both within the induction period and in the delivery of each module. Within pre course materials students are directed to a range of texts in relation to study skills focusing on activities such as how to write their ethical approval and thesis.
